Reflections from a Renewing Heart

The following story is a true account of how I found hope and regenerative results from a medical treatment, a treatment which I can only call a miracle. It traces my struggle to find a viable therapy or cure for my heart disease. And it turned me from conventional medicine to stem cell therapy, something I had scarcely given credence to beyond the “wonder drug” appellations I’d heard applied to it by some and ballyhooed by others.

I’d begun to wonder early this year (2010), whether either of my former heart specialists could be regarded as ‘experts’ in the field, for neither seemed to know anything about the groundbreaking Adult Stem Cell (ASC) therapy’s healing effects on end-stage heart patients like me; nor, it seemed, did they want to know. Even after I shared my findings on VesCell’s credentials, they seemed intent on dismissing my hopes about ASC, and instead giving me medication that seemed to merely accompany me on a slow, steady decline in my health. I was excited about VesCell’s clinical trials, journal publications, eminent physicians, significant

scientific awards, and many of the remarkable patient testimonials, but to no avail.

The good doctors met my sense of wonder and hope with an indifference that implied I couldn't possibly know what I was talking about. **I was just the ignorant patient after all.** They told me, "stem cell therapy doesn't work." The murderous bastards had just suggested it would "be a good idea to get my family affairs in order," thus proving to me what I did not believe at first from Don Margolis: "They would rather you die than see you improved by another doctor!"

Yes, they encouraged me to continue my medication, "Until we get it right," they said. "Getting it right" meant taking pills to prevent further cardiac arrests like the one I'd experienced 18 months earlier, and correcting their intolerable side-effects of constant drowsiness, incessant palpitations, photosensitivity, and a hyper-active thyroid that were making life less and less bearable for me. But even though I have mostly experienced conventional heart medicine as a kind of guinea pig being exposed to this or that treatment with relatively crude results, I am eternally grateful for its ability to keep me alive long enough to have begun my foray into the cutting-edge science of ASC treatment. To this end, I cannot to overemphasize my gratitude for the defibrillator I had fitted after my cardiac arrests. Even though the electrical shocks from it have been traumatic, it has saved my life from deadly ventricular fibrillations on three separate occasions, and has preserved me to write about my experience with ASC, and hopefully, help you.

Useless, Dangerous Therapies Plague Heart Patients While Super-Safe Stem Cells are kept from them

The Repair Stem Cell Institute (RSCI) www.RepairStemCells.org has constantly warned patients about the overuse of profitable, but frequently useless and always dangerous “standard” heart procedures in the medical system.

Your doctor says you need a bypass, he connects you to the surgeon, your insurance pays that surgeon an outrageous fee, your doctor makes 2000 bucks from the surgeon (and/or the hospital), possibly more. But the totally brainwashed (by the billion dollar ad campaign to “Ask Your Doctor”) patients think he knows something and that he cares. He knows little and cares about his income. Study: Too many heart patients get angiograms

A troublingly high number of U.S. patients who are given angiograms to check for heart disease turn out not to have a significant problem, according to the latest study to suggest

Americans get an excess of medical tests.

The researchers said the findings suggest doctors must do better in determining which patients should be subjected to the cost and risks of an angiogram. The test carries a small but real risk — less than 1% — of causing a stroke or heart attack, and also entails radiation exposure.

ED NOTE: “doctors must do better” What a joke. These hustlers with MDs after their names ARE doing better where it counts, in their bank accounts, never caring a bean for the patient’s risk.

"We can do better. There is no doubt in my mind," said Dr. Ralph Brindis of the [University of California, San Francisco](#), one of the study's authors.

Every year in the United States, more than a million people get an angiogram, in which a thin tube is inserted in the arm or groin and threaded up to the heart to check for blocked arteries that could lead to a heart attack. Dye is injected through the tube to make blockages show up on X-rays.

Angiograms are often given to patients who might be having a heart attack or have symptoms that suggest a serious blockage. They are also sometimes done on people who may have some less clear-cut symptoms, like shortness of breath, or no symptoms but some risky traits like high cholesterol and an abnormal result on another heart test. This group accounts for about 20 to 30% of angiogram cases.

In the study, nearly two-thirds of the patients in this second group **were found to have no serious blockages – none – zero!**

The researchers could not establish why so few proved to have heart disease. But Dr. Harlan Krumholz, a Yale cardiologist and

health-outcomes researcher unconnected to the study, said he thinks the problem arises **because doctors are afraid of missing something, and also getting sued.**

"We fear doing too little," he said. "I think that we developed a culture where people feel that doing more and knowing more is always the proper course. What that does is sometimes lead us to overuse."

ED NOTE: RSCI claims there are two reasons why the USA medical system is the most expensive and least effective system in the entire developed world:

1—It is fully controlled by corporations and by lawyers, NOT by doctors.

2—The only goal is profits, not patient improvement—ever!

Researchers said more study is needed to sort out how to better select patients for an angiogram. For now, experts suggest patients in the category studied by the researchers question their doctors about the need for the test and the risks and alternatives.

Defibrillators (ICDs) not as safe as they should be, but they are very profitable to Big Medicine, to the implant doctors, and to the referring doctors.

Implantable cardioverter-defibrillator (ICD) shocks may contribute to mortality risk, researchers suggested.

Patients who got a jolt of any kind from their ICD were 55% more likely to die over a nearly 4.5-year period than those who didn't

($P=0.02$), Merritt Raitt, MD, of the Oregon Health & Science University and VA Medical Center in Portland, and colleagues found.

More shocks predicted higher mortality despite adjustment for baseline predicted risk, the group reported online in *Heart Rhythm*.

However, anti-tachycardia pacing didn't have the same effect (hazard ratio for death 0.73, $P=0.41$).

These results "raise concerns that shocks themselves may be **the cause of** an increased risk of death and are not just a marker of increased risk due to a deteriorating substrate that leads to the arrhythmias and shocks," they pointed out in the paper.

Higher voltage shocks may affect electrophysiological and hemodynamic function with direct myocardial damage, the researchers noted.

Shocks have been linked to anxiety, post-traumatic stress disorder, and depression -- all of which may contribute to mortality risk, they added.

Doctors at top U.S. medical centers are increasingly worried about a flourishing stem cell underground where patients get expensive, untested and unregulated treatments that are promoted as stem cell therapy.

The only currently approved uses for stem cell therapy are bone marrow transplants to treat patients with leukemia and sickle-cell anemia.

Critics say the stem cell infusion can be expensive, costing \$10,000 or more, and is not covered by insurance. The treatments have never been through clinical trials mandated for other therapies by the Food and Drug Administration to test their safety and effectiveness, and as a result are not **FDA** approved.

"We don't have any approved stem cell therapy for heart patients in the U.S. or anywhere in the world," says Wael Jaber, a [Cleveland Clinic](#) heart specialist. Jaber says he learned of the stem cell clinics from a patient who told his doctors he paid thousands for stem infusions for coronary artery disease.

Stem cells hold promise because they are the precursors of other cells in the body and offer hope for regenerative medicine. The only currently approved use for stem cell therapy are bone marrow transplants, used for 40 years to treat patients with leukemia and sickle-cell anemia.

ED NOTE: and the only one which will ever be approved by the FDA owned and operated by Pharma which kills thousands every year by cheating on clinical trials and then approving those drugs with “their” FDA staff. (5)

Virtually every other stem cell therapy is highly experimental, doctors

say.

No one knows exactly how many doctors in the U.S. and abroad provide patients with untested stem cell therapies. But the phenomenon has provoked concern among such groups as the [International Society](#) for Stem Cell Research and the non-profit [ALS Therapy Development Institute](#).

"It's a concern of the entire research and medical community," says Steven Perrin, chief science officer for the ALS group. "They're being hyped around the world."

The International Cell Medicine Society, a professional group for doctors who provide stem cell therapies to patients, claims more than 1,000 members. And an online patients' discussion forum called Stem Cell Pioneers has 1,200 members who say they have had stem cell therapy or are seeking it.

U.S. doctors who use the purported stem cells for

treatment contend they're not subject to FDA regulation because they simply collect patients' stem cells from blood, bone marrow and fatty tissues and reinfuse them without altering them much.

FDA regulations allow doctors to infuse patients with their own cells, so long as the cells are only "minimally manipulated" and not significantly altered.

"Unfortunately, there are many loopholes in FDA regulations," says [George Daley](#), director of stem cell transplantation research at Children's Hospital in Boston. The FDA declined to comment for this story because the agency is mired in litigation over its power to regulate stem-cell clinics.

FDA's adversary in that litigation is Colorado orthopedist Christopher Centeno, who treats joint ailments with stem cells. Centeno argues that FDA regulations give doctors latitude to develop new procedures for treating patients. As soon as this fall, he says, a federal judge will decide.

Daley says he sympathizes with the desperation expressed by critically ill patients —and with their doctors' eagerness to try new things. Still, he says, it pays to be cautious.

"Lots of patients have been harmed," Daley says, "by otherwise well-intentioned but misinformed practitioners."
